Arctic Program Coordinator

This position works to honor, respect, and enhance communications between Indigenous and Alaska-based groups on environmental justice campaigns in Arctic Alaska. This position would increase capacity for land and water defense in Arctic Alaska and ensure communication and coordination between Alaska-based partners and national defense campaigns. This position will be key in mobilizing and engaging Alaskans, and others across the U.S. and the circumpolar North, towards the deescalation of climate chaos-inducing resource extraction. This position will help foster needed communication between National campaigns, Alaska-based organizations, Native organizations, and tribal governments (local and nationally).

Position Goals

- 1. Ensure Alaska Native land and water stewardship and cultural way of life is at the forefront of Northern Alaska environmental campaigns largely the Arctic National Wildlife Refuge, as well as the Western Arctic and Arctic Ocean;
- 2. Bridge communications between local Alaska organizing entities environmental, tribal, grassroots, legal, and policy;
- 3. Bridge communications between Alaska and national campaigns, contributing to national strategy, messaging, and outreach; and
- 4. Mobilize support for shared goals, and in particular, in accordance with Alaska Native tribal entities.
